

ACADEMIC/RESEARCH LICENSE AGREEMENT

THIS LICENSE AGREEMENT is made and entered
into the day of 200

hereinafter called FZR and

hereinafter called "LICENSEE".

WHEREAS, FZR considers the software and documentation described in Schedule A (hereinafter called the "SYSTEM PACKAGE") to be valuable proprietary information, yet wishes to allow LICENSEE's researchers, faculty, students and employees access to the SYSTEM PACKAGE for academic and research purposes.

NOW THEREFORE, FZR grants to LICENSEE a personal, royalty-free, non-exclusive, non-transferable license to use the SYSTEM PACKAGE according to the terms and conditions that follow.

1. *Confidentiality and Security.* LICENSEE recognizes and acknowledges the confidential, proprietary nature of the SYSTEM PACKAGE and agrees to maintain its confidentiality. LICENSEE agrees to instruct its faculty, students, researchers, employees or other authorized persons having access to the SYSTEM PACKAGE not to copy, duplicate or otherwise disclose the SYSTEM PACKAGE to third parties. LICENSEE further agrees to effect normal security measures to safeguard the SYSTEM PACKAGE from theft or from access by persons other than those persons authorized by LICENSEE to have access to the SYSTEM PACKAGE, and to notify FZR promptly and in writing of the circumstances surrounding any possession, knowledge or use of the SYSTEM PACKAGE, or any portion thereof, by anyone other than those authorized.
2. *Fee.* LICENSEE agrees to pay to FZR the distribution fee specified in Schedule A. The distribution fee is due and payable in advance.
3. *Maintenance.* LICENSEE acknowledges that the SYSTEM PACKAGE is being supplied "as is," without any accompanying support services, maintenance or future updates from FZR.
4. *Warranty and Limitation of Liability.* FZR warrants that it has the right to grant the License specified hereunder. FZR MAKES NO FURTHER REPRESENTATIONS OR WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, AS TO ANY MATTER WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE OR THAT THE USE OF THE SYSTEM PACKAGE WILL NOT INFRINGE ANY PATENT OR COPYRIGHT.

LICENSEE agrees that FZR shall not be held to any liability with respect to any claim by LICENCEE or from any third party arising from or on account of the use of the SYSTEM PACKAGE, regardless of the form of action, whether in contract or tort, including negligence. In no event will FZR be liable for consequential or incidental damages of any nature whatsoever.

5. *Use.* LICENSEE agrees that it will use the SYSTEM PACKAGE solely for internal purposes and shall not distribute or transfer it to any person or organization. Internal use shall include use for academic and research purposes. Use of the SYSTEM PACKAGE in projects with a profit organization needs the explicit permission of FZR. Nothing in this Agreement gives LICENSEE the right to sell, lease, distribute, transfer, sub-license, or otherwise dispose of the SYSTEM PACKAGE, in whole or in part. For purposes of this Agreement, the term SYSTEM PACKAGE includes both the specific software and documentation version specified in Schedule A and any future changes, upgrades, and releases that may be supplied to LICENSEE by FZR.

This License commences on the date FZR executes this Agreement and remains in force indefinitely, as long as LICENSEE complies with the terms and conditions of this Agreement.

6. *Errors and Augmentation.* In the event that LICENSEE discovers any error in the SYSTEM PACKAGE or experiences any malfunction attributable to the SYSTEM PACKAGE, LICENSEE shall promptly notify FZR of such error or malfunction. LICENSEE may augment the SYSTEM PACKAGE for its own use, may merge such augmented work with other software, or may incorporate the SYSTEM PACKAGE in other software to form an updated work, however use of the updated work is constrained by all of the terms of this Agreement. Any augmented work shall be promptly disclosed by LICENSEE to FZR and FZR shall have the right to use and the right to negotiate to obtain the distribution rights for the augmented work. The requirement to disclose augmented works does not pertain to those specific portions of code containing confidential, proprietary information belonging to LICENSEE or to a contracting agency of LICENSEE.

7. *Copies.* LICENSEE may make copies of the SYSTEM PACKAGE for *system* maintenance purposes and for installation on additional LICENSEE-owned CPUs located at LICENSEE's site. LICENSEE may print and copy documentation and manuals as described in Schedule A for the 'LICENSEE'S internal use. LICENSEE further agrees that each such necessary copy shall contain the same proprietary or copyright notices that appear on the SYSTEM PACKAGE furnished to LICENSEE by FZR.

8. *Credits.* All credits in the SYSTEM PACKAGE, both in listings and/or documentation, whether names of individuals or organisations, will be retained in place by the Licensee. The Licensee will acknowledge in any published copy or in any other use of the SYSTEM PACKAGE the authorship of the SYSTEM PACKAGE and the fact that the SYSTEM PACKAGE was developed by the Licensor. In particular in publications and presentations of results obtained by the SYSTEM PACKAGE the authorship will be acknowledged by the Licensee.

9. *Site-Wide Use.* LICENSEE agrees that the SYSTEM PACKAGE shall be used solely on CPUs located at LICENSEE'S site that are under LICENSEE'S administrative control.

10. *Title.* LICENSEE agrees that the license granted hereunder does not convey any title or copyright to the SYSTEM PACKAGE or to any materials associated therewith.

11. *Restrictions on Representations to Others.* Nothing in this Agreement shall be construed as conferring rights to use in advertising or publicity any trademark or name of FZR without the explicit written permission of FZR. LICENSEE will not, without the prior written consent of FZR, use any trademark, service mark, trade name or other designation of FZR to identify any of LICENSEE'S products or services, or represent, directly, or indirectly, that any product or service of LICENSEE is a product or service of FZR.

12. *Termination.* If LICENSEE fails to actively use the SYSTEM PACKAGE or fails to fulfill any of its obligations under this Agreement, FZR may at its option terminate all rights granted hereunder. Within thirty (30) days of receiving written notification of such termination from FZR or if Agreement is terminated for any other reasons, LICENSEE shall deliver to FZR all copies of the SYSTEM PACKAGE in its possession.

LICENSEE's obligations under sections 1, 6, 11 and 13 of this Agreement shall survive any termination of this Agreement.

13. *Export.* LICENSEE certifies that it will not make available or export any portion of the SYSTEM PACKAGE to any foreign country in contravention of any law or regulation of the Federal Republic of Germany.

14. *Complete Agreement.* It constitutes the complete and exclusive statement of the Agreement between the parties and supersedes all previous understandings, commitments or agreements, oral or written.

15. *Governing Law.* This Agreement shall be governed by the laws of the Federal Republic of Germany.
